About the Event

Political elections and the ongoing Covid-19 pandemic have highlighted the chances and risks social media pose to democratic systems in Europe, Latin America and the Caribbean (LAC). Social media allow for more inclusive, transparent and participative public debates, to name a few benefits. However, the immediate exchange through online platforms has exposed challenges for democracies and political systems: Online disinformation, manipulation of information and hate speech sow distrust in democratic institutions, cause polarization and create instability. Particularly against the background of elections, such as recent elections in both our regions, the intentional spread of false information can disrupt key democratic processes. The question of how to better coordinate, regulate and harmonize how disinformation is handled requires cooperation between like-minded democratic countries at an international level.
